HOLD HARMLESS AGREEMENT

AGREEMENT made this date, _____, by and between the Town of Ludlow, a Massachusetts municipal corporation with a place of business at 488 Chapin Street, Ludlow, Massachusetts, acting by and through its Board of Public Works (the "Town") and _____ (name) of _____ (address) (the "Applicant").

The Applicant has requested permission of the Town to construct a _____ (project) on _____ (location)

within the public way in the Town of Ludlow. The Town is willing to grant such permission, subject to any established restrictions contained in the permit application, based on the terms and conditions as set forth in this agreement. The parties, therefore, agree as follows:

1. The Town grants the applicant the right to construct the project described above within the public way.
2. The applicant agrees to maintain, repair and replace said project as may be necessary at any time after its installation, and said obligations to maintain, repair and replace shall apply to all parts of the project, including those parts within the Public Way.
3. The applicant hereby Holds Harmless the Town for any further maintenance, repair, and/or replacement of the project.
4. This agreement sets forth the entire understanding and agreement of the parties hereto with respect to the subject matter hereof, and no change of modification shall be valid unless made in writing and signed by the parties hereto.
5. This agreement and the construction and interpretation of all provisions hereto shall be governed by the laws of the Commonwealth of Massachusetts.

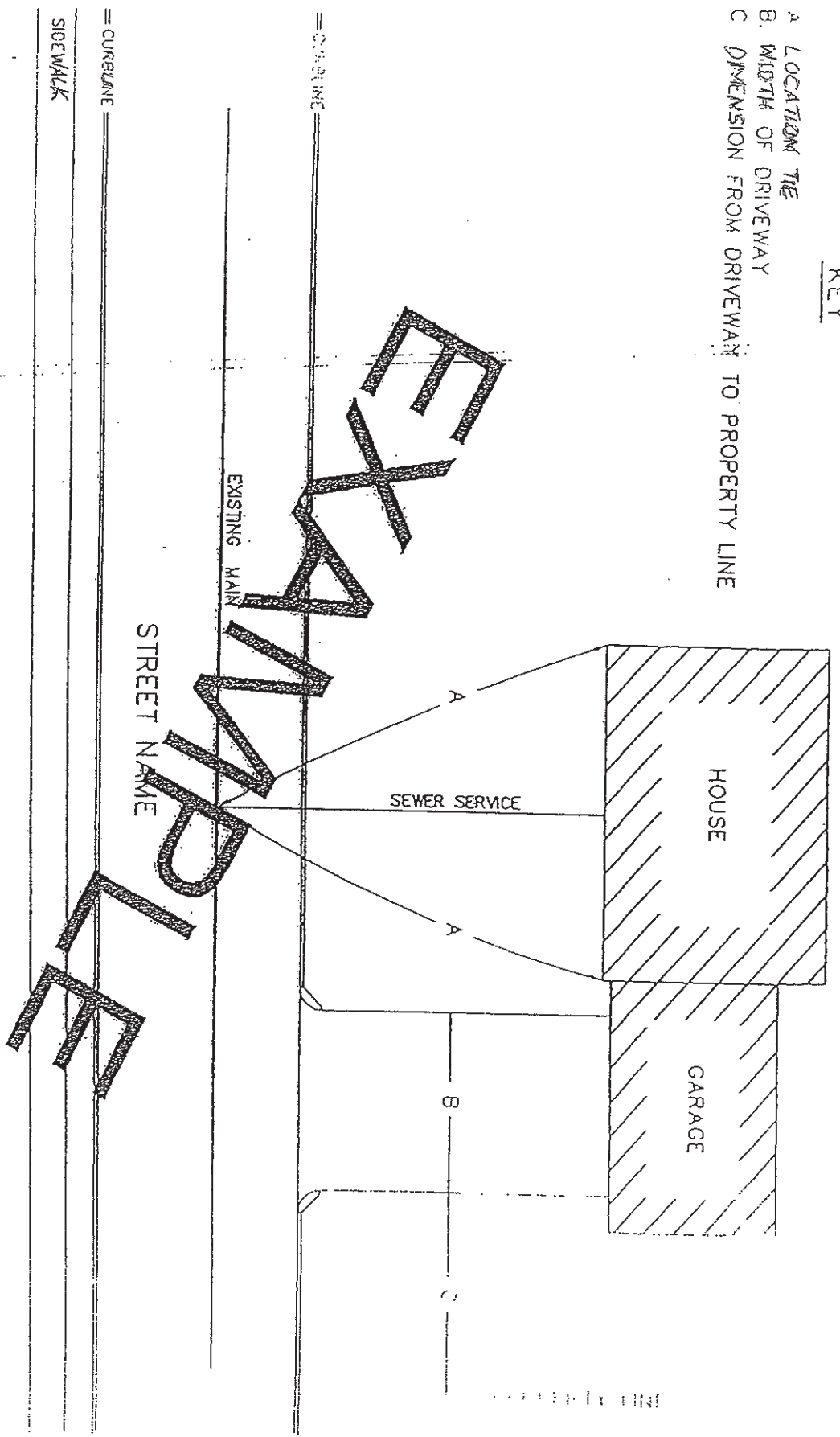
